6.2. Environmental precautions

Or pour water on spill and allow to react for more than 30 minutes. Cover with absorbent material. Remember, adding an absorbent material does not remove a physical, health, or environmental hazard. Collect as much of the spilled material as possible. Place in a container approved for transportation by appropriate authorities, but do not seal the container for 48 hours to avoid pressure build-up.
