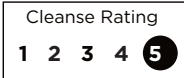

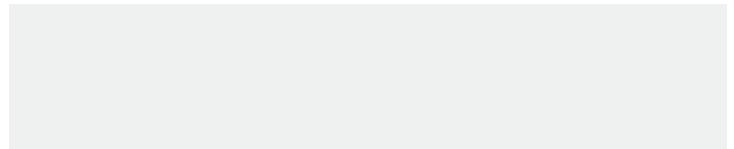
## INSTRUCTIONS FOR USE
